ITEM #1 Call Meeting to Order

Mr. Flint called the meeting to order at 1:00 PM.

ITEM #2 Acknowledge Notice of Meeting Proof of Publication

The Proof of Publication of the Notice of Meeting was included in the agenda package and made part of the minutes.

ITEM #3 Approval of Minutes of the June 13, 2017 Annual Landowners' Meeting

Mr. Flint stated that the next item was the approval of the minutes of the June 13, 2017 annual landowners' meeting. He asked if there were any questions, additions or deletions.

There being none,

On MOTION by Ms. Donton, seconded and carried, with all in favor the minutes of the June 13, 2017 Annual Landowners' Meeting were approved, as presented.

ITEM #4

Accept any Nominations from the Floor to Fill the Expiring Supervisors' Positions

ITEM #5

Verify Landowners Present that are Planning to Vote in Person and Number of Voting Units Represented by Each. Cast Votes and Record Totals

The landowners present did not elect to cast votes.

ITEM #6

Tabulate Total of Votes Cast in Person and by Proxy

Mr. Broome stated that there were 1,996 votes for Debra Donton; 13 votes for Jarrod Cooper; 6 votes for Roy Miller; 1 vote for Gilbert Chestnut; 1 vote for Carl Murphy and 1 vote for Richard Ungaro.

Debra Donton was elected to the 2018 to 2023 term on the Board of Supervisors.

Mr. Broome stated that there were 1,898 votes for compensation and 45 votes against compensation with 59 abstaining. The Board of Supervisors will receive compensation for attending District meetings.

ITEM #7

Annual Report of District Engineer

Mr. Mahler presented his annual report and stated that there were issues on the C-4, C-10 & C-11 canals. He stated that the C-10 issues were mainly due to the construction at the 528 where a lot of grading was done. He stated that the C-4 canal had several washouts and that it had old pipes and repairs will need to be made in the near future. He stated that the C-11 canal against Orange Blossom Trail has a large washout that was caused by a failure of Orange County and FDOT systems. He stated that a tent got caught in the pipe that got pushed out but that FDOT agreed to fix the area and it looks better. He stated that DEP has also been dealing with turbidity issues in the area but that the water quality was in generally good condition. Brief discussion ensued.

Mr. Mahler reported that the Orange County Public Works director was retiring soon and was not certain who the successor would be at this time. He stated that the canal banks and driving surfaces would be looked at this year to get a repair list prepared as they are 49 years old. He stated that the ponds were in generally good shape. He reported that one of the ponds had ducks die off but that the cause was still be determined. He also reported the DEP notified him

that salt water got discharged from Sea World unintentionally due to a power outage so the water would need to be monitored but was not a major issue. Discussion ensued.

Mr. Mahler stated that repairs were made to the C-5 canal animal gate and the Area 1 pond.

Annual Report of the District Legal Affairs

Mr. Broome reported that there was no pending or threatened litigation. He stated that the legal work mainly consisted of attending monthly meetings, reviewing minutes & agendas, the renewed lease agreement and the renewed Interlocal agreement with Orange County.

MINUTES OF THE MONTHLY MEETING OF THE BOARD OF SUPERVISORS OF VALENCIA WATER CONTROL DISTRICT

May 14, 2019

The monthly meeting of the Board of Supervisors of VALENCIA WATER CONTROL DISTRICT was held at 1:00 P.M. on Tuesday, May 14, 2019, in the Lake Ridge Village Clubhouse, Williamsburg Subdivision in Orlando, Florida. Present were Supervisors William Ingle, Ed Neal, Debra Donton, Brian Andrelczyk and Roy Miller. Also in attendance were the following: Stephen F. Broome, District Attorney; George S. Flint, District Director; David Mahler, District Engineer; Stacie Vanderbilt, District Administrative Assistant; Teresa Viscarra, District Accounts Payable; Dan Brown, Sthern Environmental.

ITEM #1 Call Meeting to Order

Mr. Flint called the meeting to order at 1:03 PM.

ITEM #2 Appointment of President of the Board of Supervisors

Mr. Flint gave the Board an overview of why the President of the Board was needed. Brief discussion ensued. Mr. Miller volunteered to serve as President and Mr. Neal nominated Roy Miller. There being no other nominations, Mr. Miller was appointed President of the Board of Supervisors.

ITEM #3

Approval of April 9, 2019 Minutes

Mr. Flint stated the next item was the minutes from the April 9, 2019 monthly meeting. He asked if there were any corrections, deletions or additions. There being none,

On MOTION by Ms. Donton seconded and carried, with all in favor the minutes of the April 9, 2019 Monthly Meeting of the Board of Supervisors were approved.

ITEM #4

General Fund Financial Reports

Mr. Flint stated the unaudited financials as of April 30, 2019 were included in the agenda package and asked if there were any questions.

Mr. Neal stated he was used to seeing the current year and prior year in the financials.

Ms. Viscarra stated that the financials never reflected both, only the budget.

Mr. Flint asked if they could be changed to reflect it.

Ms. Viscarra stated that due to the early date of the meetings, that information would have to be brought to the meeting.

Mr. Flint advised that financials in the new format would be drafted and brought back next week.

Mr. Miller asked if mowing was done earlier than contracted then how would it affect the financials.

Mr. Flint stated that it would be reflected as over budget by one month of service but that there is funding in other places that the money could be moved around.

The District's financial reports for the period ending 4/30/19 were accepted as distributed.

ITEM #5

Engineer's Report

Mr. Mahler stated that there were no new permits pending. He reported that it was discovered an Orange County vendor was drawing out of one the District's canals without permission. He stated that he addressed the matter and was told that they thought the canal was County owned and that they have since stopped.

ITEM #6

Attorney's Report

There being none, next item followed.

ITEM #7 Bud

Budget for Fiscal Year 2020, Proof of Publication and Tax Levy Resolution

Mr. Flint reviewed the budget by line item with the Board. He stated that there was \$458,000 in revenue projected and that he had provided the Board with a Capital Improvement Plan with the first year of planned projects detailed in the back of the budget. He stated that the Engineer is preparing proposed specs for proposals that will be brought back in future meetings.

Mr. Neal asked why the account lines didn't add up.

Ms. Viscarra explained that the excess funds were included in the final budget number and it's not appropriated like it was last year. Mr. Flint noted that no members of the public were present to provide comment on the budget.

On MOTION by Mr. Ingle seconded and carried, with all in favor the Fiscal Year 2020 budget was adopted and the Tax Levy Resolution approved.

ITEM #8

Director's Report

A. Consideration of Agreement with VGlobalTech to Provide Website ADA Compliance Services

Mr. Flint stated that the District currently has a website that GMS prepared at no additional cost, for compliance items like meeting agendas and other public records. He explained how the ADA compliance issue came about with an individual suing several special districts and that part of the settlement was to make all the websites complaint within 24 months. He advised that it does not prevent anyone else from suing so GMS found a company that was the most cost effective to convert all their clients' websites. He stated that he felt the proposal was cost effective for the District and recommended the one-time option at \$2,375 as that also included human auditing to test that the website works as intended.

Mr. Miller asked if the \$2,375 would be in addition to what they pay now.

Mr. Flint replied yes.

Mr. Miller asked if they have to pay the \$1,350 as well.

Mr. Flint replied no, he recommended not choosing the monthly maintenance option.

On MOTION by Ms. Donton, seconded and carried, with all in favor, the proposal from VGlobalTech to provide website ADA compliance services at the one-time amount of \$2,375.

B. Call Log

Mr. Flint presented the call log in the agenda to the Board. There were only three calls in the last month that were all handled.

C. Proposal from Sthern Environmental, Inc.

Mr. Brown stated that there are two access ramps at the C-12 canal behind the Racetrac where there is construction going on. He stated that the contractor working in the area is

dumping illegally so a barrier will need to be put up. Otherwise, money would be spent cleaning out the canal and certain items, such as tires, cost for disposal.

Mr. Neal asked if there was any benefit to putting up signs telling people not to dump.

Mr. Brown responded no, as people typically don't regard signs.

On MOTION by Mr. Andrelczyk seconded and carried, with all in favor the proposal from VGlobalTech to install security gates at the access ramps of the C-12 canal was approved.

ITEM #9

Other Business

Mr. Miller stated that the Parkview, Somerset and Waterview neighborhoods have had break-ins recently where people are coming in through the sliding glass doors of the homes. He advised that the Waterview HOA has discussed putting a gate or fence blocking access to the homes from the common area. He reported to the Board that last week, two men were spotted on the pond with fishing poles but no bait, so the Sheriff was called to trespass the individuals, but a gun was found on the car seat so that issue eclipsed the trespassing. He also reported that over the weekend, two more people showed up, a man and a woman, so the Sheriff was called again and had to chase them through the community. He mentioned that the area where the men parked has a 'No Trespassing' sign but that it's not visible behind the bushes if you park in front of them. He began going through the pictures he had passed out to the Board earlier showing where people are accessing the neighborhoods from the common areas. He stated the HOAs may approach the District about putting up a fence or barrier.

Ms. Donton stated that the 'No Trespassing' signs are mostly on the borders of the District areas but that if the HOAs want any barriers installed, they would need to maintain them.

Mr. Miller suggested putting thorny bushes around and placing the signs in front of them.

Ms. Donton stated that Lake Ridge has the same issue with people accessing the neighborhood from Central Florida Parkway coming to fish in the pond. She stated that there were not many options for the District to remedy this and that a fence may not be the solution. Brief discussion ensued.

RE: VWCD Canal C-4 outfall structure replacement CPH Project Number 6816.06

As requested, CPH is providing this proposal letter for engineering services to address the concerns with the condition of the existing outfall structure to the C-4 Canal. The structure is showing signs of deterioration and needs to be removed and replaced. The structure is located at the west end of the C-4 Canal, between Sea harbor Drive and Westwood Boulevard.

More specifically, the following proposal outlines the proposed repairs of the existing outfall structure, drain pipes and concrete end wall, which drains into the west end of the C-4 Canal.

Currently, the existing structures and pipes are deterioration and are in need of repair and/or replacement. CPH proposes to have the following outfall areas surveyed to verify the invert elevations, top elevation, weir elevations, dimensions, and type of the existing structure (material):

- Outfall structure
- Control structures (set of 3)
- Canal banks, side slopes and current water elevation

Upon receipt of the survey, CPH will prepare design plans to remove and replace the outfall with a new structure, specify to line the existing storm pipe and replace the metal control structures. The plans will depict the required grading and construction details necessary to complete the work.

CPH also proposes to provide Construction Administration services during the work. The services will include review of shop drawings, attend one pre-construction meeting with the Owner and Contractor, perform periodic site inspections as the work progresses, and perform a substantial and final walk through upon completion of the work.

This work is considered remedial repair work, therefore, no permitting through the South Florida Water Management District is anticipated or proposed. If during the design



process it is determined that permitting will be required, an amendment to this proposal will be submitted.

The fee for the surveying services is \$3,800.00 and includes the location noted above. The fee for the engineering design scope of services described herein will be provided for an hourly, not to exceed fee of \$7,925.00. The base services are described above and broken down as follows:

Services:

- 1. Provide Survey
- 2. Prepare design plans and details
- 3. Contractor / pre-construction meeting
- 4. Review shop drawings
- 5. Periodic site inspections
- 6. Substantial and final inspections
- 7. Estimated Expenses
